

You work as an IT Administrator in a small town company. The company is expanding and is looking to move their business on-line. At the moment the company has an internal network for file sharing and storage. You have been asked by the Director to research and recommend an internet system for the company.

All research should be done using the Internet ensuring that all information is reliable, accurate and current.

Bookmark **all** visited web pages as this will be used as evidence.

Please ensure that you reference **all** web pages visited.

Read all of the instructions carefully and complete the tasks in the order given.

Task A - Internet Connections

Using your **Answers 307 B** document, provided by your assessor research and describe **two** different types of connection methods. Recommend **one** suitable method for the company to access the internet.

Use a variety of sources to ensure validity and accuracy of your research.

Note: Bookmark **all** visited web pages as this will be used as evidence.

Please ensure that you reference **all** web pages visited.

2 Using your **Answers 307 B** document, provided by your assessor research and describe the hardware which is required for the recommended connection method.

- 3 Using your **Answers 307 B** document, provided by your assessor list the benefits and drawbacks of the connection method you have recommended.
- 4 Using your **Answers 307 B** document, provided by your assessor research and identify **two** Internet Service Providers (ISP), taking into consideration cost, speed and reliability, recommend **one** of these ISP for the company to use.
- Using your **Answers 307 B** document, provided by your assessor for the recommended connection method you have researched, write a description of the procedure required for installing and configuring the connection, including testing.

Task B - Browser Settings

- 1 Using your **Answers 307 B** document, provided by your assessor research and explain **three** ways to improve browser performance and adjust browser settings to aid navigation.
- 2 Customise the web browser to improve browser performance and modify browser settings to aid navigation using the **three** researched methods.
